MOTION FOR PERMISSION TO APPEAR PRO HAC VICE

Pursuant to Gov. Bar R. XII(2)(A)(6), Dina Vespia (“Movant”), attorney for Palmco Energy OH, LLC (“Palmco Energy”), hereby moves the Public Utilities Commission of Ohio (“Commission”) to grant Movant permission to appear *pro hac vice* and participate as counsel or co-counsel before the Commission in the above-referenced case.






