Dear Ms. McNeal:

Pursuant to the Joint Stipulation and Recommendation filed February 14, 2014 between Vectren Energy Delivery of Ohio, Inc. ("Vectren"), the Staff of the Ohio Power Siting Board ("OPSB Staff"), and the City of Dayton recommending that the Ohio Power Siting Board ("Board") issue a Certificate of Environmental Compatibility and Public Need subject to a number of conditions.

Condition No. 22 of the Joint Stipulation and Recommendation requires the following:

Prior to the commencement of construction activities that require permits, licenses, or authorizations by federal or state laws and regulations, the Applicant shall obtain and comply with such permits, licenses, or authorizations. The Applicant shall provide copies of permits and authorizations, including all supporting documentation, to Staff within seven days of issuance or receipt by the Applicant. The Applicant shall provide a schedule of construction activities and acquisition of corresponding permits for each activity at the preconstruction conference.

In compliance with Condition No. 22 of the Joint Stipulation and Recommendation, and as referenced in Section 4906-15-04(D)(1) of the Amended Application filed November 15, 2013, attached for filing is a copy of the permit and correspondence with the City of Dayton for Vectren to work within the 100-year floodplain around Mill Creek.

Michael,

Typically the bore pits are only open for a week, the estimated time required to directionally drill the pipe and tie it in with the rest of the pipeline. The minimum depth of the pipeline below the surface is four feet and will be a minimum of five feet below the bed of Mill Creek. There will be no permanent structures above the surface, other than the required pipeline safety markers at intersections, stream crossings and other locations as needed. These markers are roughly 4" wide by 36" tall, some of which will be test stations for monitoring the cathodic protection on the pipeline.




