**Re:** In the matter of the authorization of CSX Transportation to install active grade crossing warning devices in Seneca and Wood Counties  
**Date:** February 26, 2014

The Ohio Rail Development Commission (ORDC) has authorized funding for CSX Transportation (CSX) to **install mast-mounted flashing lights and roadway gates** at the following locations:

Seneca County, Loudon Township, near Fostoria, Green Rd/TR 108, DOT# 228779S

Wood County, Middleton Township, near Perrysburg, Reitz Rd/TR 101, DOT# 155810W

The crossings were surveyed in September of 2012, and August of 2013, respectively, and were found to warrant the upgrades.

The projects will be paid for with federal funds, and are actual cost. As the plans and estimates have already been submitted and approved, staff requests a Finding & Order with completion of the projects in nine months. Construction may commence at once. Staff requests that the following language be incorporated in the Entry:

**It is expected that all work necessary for FHWA acceptance of the warning devices will be completed by the in-service due date and that the railroad will be responsible for this work. This work includes, but is not limited to:**

**Any ancillary work to make the warning devices function as designed and visible to the roadway user, and**

**MUTCD compliance, including minor roadway work if necessary.**

A suggested case coding and heading would be:

The Force Account Estimate dated 1/8/2014 along with the Proposed Crossing Layout for the referenced project has been reviewed and is acceptable. CSX Transportation may proceed with the construction of the proposed grade crossing warning system in accordance with the abbreviated plan. This authorization is made with the stipulation and understanding that the approved estimate may contain entries for items or activities that may be cited and found to be ineligible for federal participation during the project audit. Reimbursement of eligible actual cost is limited to \$207,730.00. Additional costs must be approved in writing by the Ohio Rail Development Commission (ORDC) prior to being incurred. Emergency verbal authorizations by ORDC may be permitted and will be confirmed by ORDC in writing within ten (10) business days of the verbal approval.

This authorization is contingent upon CSX Transportation accepting the following instructions:

The Force Account Estimate dated 10/25/2013 along with the Proposed Crossing Layout for the referenced project has been reviewed and is acceptable.
