ENTRY

The attorney examiner finds:

- (1) The Dayton Power and Light Company (DP&L) is a public utility as defined by R.C. 4905.02 and, as such, is subject to the jurisdiction of this Commission.
- (2) On December 21, 2012, DP&L filed an application seeking authority to recover storm Operation and Maintenance (O&M) expenses for all major event storms in 2011 and 2012, as well as certain 2008 storm O&M expenses. DP&L also requests authority to implement a storm cost recovery rider to recover all costs associated with major storms going forward and to defer O&M costs until they are recovered through the rider.
- (3) By Entry issued on October 23, 2013, the attorney examiner adopted a procedural schedule in this matter. Subsequently, on December 18, 2013, the Commission issued an Entry on Rehearing with a modified procedural schedule containing an evidentiary hearing date of February 11, 2014.
- (4) On February 3, 2014, DP&L filed an unopposed motion to continue the evidentiary hearing, with a request for an expedited ruling. The attorney examiner granted DP&L's motion and rescheduled the evidentiary hearing for March 10, 2014.

- (5) Subsequently, on March 3, 2014, DP&L again filed an unopposed motion to continue the evidentiary hearing with a request for an expedited ruling. DP&L certifies in the motion that no party objects to the issuance of an expedited ruling. The attorney examiner finds that DP&L's motion to continue the evidentiary hearing is reasonable and should be granted.
- (6) The evidentiary hearing in this matter will commence on April 21, 2014, at 10:00 a.m., at the offices of the Commission, 180 East Broad Street, Hearing Room 11-C, Columbus, Ohio 43215.

It is, therefore,

ORDERED, That DP&L's motion be granted and the evidentiary hearing in this matter scheduled for April 21, 2014, at 10:00 a.m., at the offices of the Commission, 180 East Broad Street, Hearing Room 11-C, Columbus, Ohio 43215. It is, further,

ORDERED, That a copy of this Entry be served upon all parties of record.
