MEMORANDUM IN SUPPORT

On December 4, 2013 by order this Commission required the draft audit report to be submitted by April 2, 2014 and the final audit report by April 18, 2014. As this audit covers two years rather than the more traditional one, the auditor has found that a full examination requires more time than was initially thought. Postponing the due dates by three weeks will allow sufficient time for the auditor to complete a thorough examination and will provide the Commission with the information needed to adequately review the subject matter of the case. Therefore the Staff asks that the due dates be moved to April 23, 2014 and May 9, 2014, respectively. We do not believe that moving these dates will prejudice any party and should allow a complete development of the issues.
