## Re: Vectren Energy Delivery of Ohio, Inc. Z-167 Pipeline Rerouting Project, OPSB Case No. 13-1651-GA-BTX

Dear Ms. McNeal:

On March 17, 2014, the Ohio Power Siting Board ("OPSB") issued an Opinion, Order, and Certificate authorizing Vectren Energy Delivery of Ohio, Inc. ("Vectren") to construct, operate, and maintain the above referenced pipeline project, subject to the conditions set forth therein.

Within this set of conditions, **Condition #5** requires that:

At least 30 days before the preconstruction conference, Vectren shall submit to Staff, for review and acceptance, one set of detailed engineering drawings of the final project design, temporary and permanent access roads, construction staging areas, and any other associated facilities and access points, so that Staff can determine that the final project design is in compliance with the terms of the certificate. The final project layout shall be provided in hard copy and as geographically-referenced electronic data. The final design shall include all conditions of the certificate and references at the locations where Vectren and/or its contractors must adhere to a specific condition in order to comply with the certificate.

Also within this set of conditions, **Condition #22** requires that:

At least seven days before the preconstruction conference, Vectren shall submit to Staff, for review and acceptance, a copy of all National Pollutant Discharge Elimination System (NPDES) permits, including its approved SWPPP. Any soil issues must be addressed through proper design and adherence to the BMPs of the Ohio Environmental Protection Agency (Ohio EPA) related to erosion and sedimentation control.

This letter is to inform the OPSB Staff that Vectren is in compliance with **Conditions #5 and #22.** Attached to this letter, as Attachment A, is correspondence between Melinda Stahl, consultant to Vectren, and Ed Steele, OPSB Staff, confirming the delivery of the engineering drawings and the SWPPP on April 1, 2014. Also attached to this letter, as Attachment B, is correspondence between Melinda Stahl and Grant Zeto, OPSB Staff, on March 31, 2014, indicating that the engineering drawings were also delivered to OPSB as geographically-referenced electronic data.
