In accordance with Ohio Administrative Code Chapter 4901:1-27-10 "Material changes in business", notice is provided herein that ETC ProLiance Energy, LLC, a licensed Competitive Retail Natural Gas Supplier has been acquired by Exelon Generating Company, LLC and has had its name changed to Constellation ProLiance, LLC.

On July 9th 2013, the Public Utilities Commission of Ohio issued ETC ProLiance Energy, LLC Competitive Retail Natural Gas Supplier Certificate 02-030G(6) in Case No. 02-1909-GA-CRS.

On March 31st 2014, Exelon Generating Company, LLC acquired ETC ProLiance Energy, LLC. Also, ETC ProLiance Energy, LLC's name was changed to Constellation ProLiance, LLC. Please refer to Attachments A and B.

Constellation ProLiance, LLC is a direct subsidiary of Constellation NewEnergy-Gas Division, LLC, a licensed Competitive Retail Natural Gas Supplier pursuant to License 09-153G(3). Both of these entities are indirect wholly owned subsidiaries of Exelon Generating Company, LLC. Please refer to Attachment C.

Please note no customers are currently being served pursuant to Certificate 02-030G(6) and none are currently anticipated.


