Please find the attached tariff ordered to be filed in the 12-3255-EL-RDR by the Commission's April 2, 2014 Opinion and Order in this case for Ohio Power Company. The rate reflected in the attached tariff is updated in accordance with the Opinion and Order and Stipulation, including the clause found at page 3 (IV-B) of the Stipulation that states the calculation of the carrying charge included in the rate shall be figured to begin on April 1, 2013 through the start of collection. The start of collection begins April 17, 2014.

The corresponding bill message that will accompany the first application of this tariff on customer bills was discussed and approved by the Commission Staff, as provided for in the Opinion and Order.
