Mr. Steve Irwin, et al.:

As a follow-on to my conversation with your office on this date, as well our correspondence dated July 16, 2013, we understand that AEP has submitted an application for the Biers Run-Hopetown-Delano 138 kV Transmission Line Project. That application now outlines the preferred route as being what was previously referred to as the blue line.

As was our position at that time, we continue to oppose the location of what is now the preferred route. While the location of the line appears to have shifted closer to Anderson Station Road, the line remains in close proximity to our property line. At its present proposed location, it appears to be within 150-200 feet of our property line. As noted in our previous correspondence, we, as well as many of our neighbors, spend a considerable amount of time outside in that area from spring through summer and into the fall months. Due to health concerns associated with high voltage power lines, this project would impact our ability to do so.

Along with our concerns that the project would decimate the unabated view we have of the hills behind our home, our larger concern is the health implications of placing a project, with recognized electric and magnetic field (EMF) hazards, in such close proximity to a residential area. Additionally, there is evidence that indicates EMF exposure results in childhood leukemia and potentially other cancers in children. The preferred route in AEPs application not only jeopardizes the safety of the children in our sub-division, but also the children that attend Union-Scioto Schools due to the proximity of the preferred route to the schools.

Additionally, we have concerns about the impact to our property value as several of our neighbors have been advised by real estate agents that having the power lines in such close proximity to our homes and the subdivision would result in a 10-20% loss in home value. This not only impacts our property, but the other 55-60 residences within the Golf View Subdivision as well.

In closing, we are writing to reinforce our strong opposition to the proposed line in AEP's proposal due to negative impact it would have on public health, the environment, property values, and the beautiful view we have of the hills behind our home.
