Dear Ms. Wissman and Ms. McNeal:

Dominion East Ohio (“DEO”) is planning to replace 4,510 feet of 26-inch high pressure (“HP”) bare steel pipe with 4,510 feet of 30-inch high pressure coated steel pipe. This construction will run in the tree lawn and sidewalk on the south side of Cedar Road between Wrenford Road and Stone Lake Drive.

The replacement pipeline will be located entirely within DEO’s service area. The primary purpose of the replacement will be to take out of service the aging and obsolete pipeline to assure a safe and constant natural gas supply to DEO’s customers. This project is eligible for recovery as part of the Pipeline Infrastructure Replacement program. The construction of the replacement pipeline is anticipated to begin in June 2014. DEO plans to place the line in-service by September 5, 2014.

DEO submitted payment of \$2,000 in accordance with Ohio Administrative Code Rule 4906-5-11(I) so that the Construction Notice will be considered on an expedited basis. If you have any questions please call at the number listed above.
