Dear Ms. McNeal:

On February 7, 2014, Qwest Communications Company, LLC ("QCC") filed an application in the above-referenced docket for approval of an internal reorganization in which four affiliated CLEC and/or IXC entities that are certificated in Ohio would be merged into QCC and their certificates relinquished. Specifically, as a result of internal reorganization, Embarq Communications, Inc. d/b/a CenturyLink Communications (IXC), CenturyTel Solutions, LLC d/b/a CenturyLink Solutions (IXC/CLEC), CenturyTel Fiber Company II, LLC d/b/a CenturyLink Wholesale (IXC) and CenturyTel Long Distance, LLC d/b/a CenturyLink Long Distance (IXC) would be merged out of existence. This internal reorganization was deemed approved on March 9, 2014.

This letter is to provide notice that the internal reorganization described in the application took place on April 1, 2014 and consequently, the four entities identified above no longer exist as legal entities. Attached as Exhibit 1 are the Ohio Secretary of State filings confirming that each has been merged out of existence. In addition, as described in the application, QCC has changed its name to CenturyLink Communications, LLC. Attached as Exhibit 2 is the Ohio Secretary of State filing confirming the name change.
