- Condition No. 9: Clarification of language with respect to the final project design and condition compliance.
- Condition No. 17: Potential changes to permit some construction activities on nights and weekends.
- Condition No. 19: Clarification on the exact requirements of the construction access plan.
- Condition No. 20: Clarification on the exact requirements of the vegetation management plan.
- Condition No. 24: Clarification on identification of northern harrier habitat.
- Condition No. 37: Clarification on whether a general blasting plan sufficiently meets condition requirement.
- Condition No. 41: Potential changes to condition language to allow the use of Comsearch data for microwave path survey.

• Condition No. 47: Decommissioning clarifications, elimination of inconsistencies and adjustments to the Staff language.
