### DESCRIPTION OF FILING

The Applicant proposes to modify its Intrastate Access Service Tariff consistent with the Federal Communications Commission's ("FCC") Report and Order and Further Notice of Proposed Rulemaking, WC Docket Nos. 07-135, *et al.*, FCC No. 11-161 (Released November 18, 2011) and WC Docket No. 10-90 and CC Docket No. 01-92, FCC Order DA 14-434, (Released March 31, 2014).

The terminating rates for End Office - Local Switching and the End Office - Information Surcharge continue to concur with the NECA 5 rates and are a composite rate as authorized by the FCC in DA 14-434 (¶ 17).

The Applicant also proposes to combine the per minute End Office - Local Switching and the End Office - Information Surcharge for originating traffic into a composite rate. By combining these two rate elements, the originating rate structure will mirror the terminating rate structure. FairPoint will continue to bill for the Originating Transport Interconnection Charge as a separate rate element as the Terminating Transport Interconnection Charge was previously reduced to zero. The change is revenue neutral as is demonstrated in the attached work paper.
