My husband and I own and live on a farm on the corner of Fenner and Greenlee Rd. This is a third generation farm that my Grandfather first owned. This farm has some of the most fertile and productive land in the county. We depend on the income of this farm to maintain a quality and productive farm program.

This high voltage power transmission line would not only affect the value of our home but also our crop yields and income. If the proposed line would be run through our fields it would be a huge inconvenience to farm around them and take away farmable acreage.

New construction homes that have been built along Greenlee Rd. would decrease in value and eventually deteriorate into undesirable real estate.

Brukner Nature Center is a 165 acre preserve that is less than ½ mile from proposed line. I do not think this would be a very natural view for visitors to this center which does much for this community with their quality adult and children's educational programs.
