Dear Ms. McNeal:

On February 10, 2014, the Ohio Power Siting Board Staff issued a Report of Investigation approving the Construction Notice subject to a number of conditions. Condition No. 4 requires Dominion East Ohio ("DEO") to conduct no in-water work from March 15 to June 30 to reduce impacts to aquatic species and their habitat, unless coordination efforts with ODNR reflect a different course of action.

In compliance with Condition No. 4 of the Staff Report, attached for filing is a copy of an e-mail response from the U.S. Army Corps of Engineers accepting and approving DEO's proposed waiver of the in-water work restriction within Nimisila Creek in conjunction with the construction of Crossing #1 for the period of May 1 through June 30.

The ODNR - Division of Wildlife provided the following response regarding your request to waive the requirements of Nationwide Permit Regional General Condition No. 4 for Ohio Department of Natural Resources' In-Water Work Exclusion Dates for the crossing of Nimisila Creek in conjunction with the construction of Crossing #1:

"The DOW has reviewed this request and the project is eligible for a partial in-water work restriction waiver. Therefore, the DOW does not object to waiving the in-water work restrictions for the requested period from May 1 through June 30. Please note that this is a one-time waiver and waivers for subsequent years will need to be applied for separately..."

Crossing #1 was authorized via a Nationwide Permit (NWP) No. 12 verification issued by this office on January 31, 2014 and included the discharge of dredged and/or fill material into approximately 41 lf (0.011 acre) of perennial flowing stream channel (Nimisila Creek) and 0.409 acre of palustrine emergent wetland.

Your proposed waiver of the in-water work restriction within Nimisila Creek in conjunction with the construction of Crossing #1 for the period of May 1 through June 30 is acceptable and approved. Please be aware that your January 31, 2014 NWP No. 12 verification remains valid including all associated enclosures, attachments, and special conditions.
