**NOTICE OF WITHDRAWAL OF MOTION OF OHIO EDISON COMPANY, THE  
CLEVELAND ELECTRIC ILLUMINATING COMPANY, AND THE TOLEDO  
EDISON COMPANY FOR RENEWAL OF PROTECTIVE ORDER**

---

Pursuant to Rule 4901-1-24(F), O.A.C., on April 4, 2014, Ohio Edison Company, The Cleveland Electric Illuminating Company, and the Toledo Edison Company (collectively, “the Companies”) filed their Motion for Renewal of Protective Order (“Motion”). In that Motion, the Companies sought to renew the protection of, and to continue to keep under seal, the confidential and proprietary information contained in the audit report by Exeter Associates, Inc. (the “Exeter Report”). On August 15, 2012, a redacted version of the Exeter Report was filed on the docket in this proceeding and a confidential version was filed under seal. In a hearing on November 20, 2012, the Commission found that the unredacted version of the Exeter Report contained trade secrets and ordered that it remain under seal. Pursuant to Rule 4901-1-24(F), the Companies were concerned that this protection was due to expire on May 20, 2014, and thus the Companies timely moved to renew protection on April 4, 2014.

In a conference call held on April 24, 2014, various parties to this proceeding, including the Companies, respectfully requested that the Attorney Examiner issue an entry clarifying the expiration of protection for the confidential and proprietary material filed under seal in this proceeding, including but not limited to the unredacted version of the Exeter Report. On May 6, 2014, the Attorney Examiner issued an entry (the “Entry”) that extended protection until

February 13, 2015 for all of the confidential and proprietary material filed under seal in this proceeding, including but not limited to the unredacted version of the Exeter Report. In light of the Entry, the Companies hereby give notice that they are withdrawing their Motion. Pursuant to Rule 4901-1-24(F), the Companies reserve their right to seek renewal of protection at the appropriate time for the confidential and proprietary currently under seal in this proceeding, including but not limited to the unredacted Exeter Report.
