**FIRSTENERGY SOLUTIONS CORP.’S MOTION FOR CONTINUANCE OF HEARING  
SET FOR MAY 15, 2014 AND REQUEST FOR EXPEDITED RULING**

In accordance with Rule 4901-1-13 of the Ohio Administrative Code (“OAC”), Respondent FirstEnergy Solutions Corp. (“FES” or “Respondent”) respectfully moves the Public Utilities Commission of Ohio (the “Commission”) for an order continuing the hearing currently set for May 15, 2014 at 9:00 a.m. This motion is not made for the purposes of delay, but rather to allow FES adequate time to fully and properly respond to Complainant Bruce Snyder’s (“Complainant”) Amended Complaint.

On May 2, 2014, FES states that it was served with a copy of Complainant’s Amended Complaint, which raises alleged violations of the OAC for the first time. The requested continuance will allow FES adequate time to properly address these newly raised allegations, which FES would not otherwise be able to do with the hearing set to take place in five days. Moreover, additional time is also necessary to revise FES’s direct testimony as a result of these newly raised allegations, as well as to prepare a motion to dismiss the allegations contained therein. FES will be prejudiced if it is not afforded an adequate amount of time to respond and

otherwise prepare if the hearing takes place as currently scheduled, while the hearing date is of no consequence to Complainant. FES notified Complainant of its intent to seek a continuance.

In light of these time constraints, and pursuant to OAC 4901-1-12(C), FES respectfully requests an expedited ruling on this Motion for Continuance before the hearing currently set to take place on May 15, 2014.
