## FINDING AND ORDER

### The Commission finds:

- (1) Ohio Edison Company, The Cleveland Electric Illuminating Company, and The Toledo Edison Company (collectively, FirstEnergy or the Companies) are public utilities as defined in R.C. 4905.02 and, as such, are subject to the jurisdiction of this Commission.
- (2) On May 1, 2014, the Companies filed updates of their Experimental Real Time Pricing Rider (Rider RTP) and Critical Peak Pricing Rider (Rider CPP), as well as tariff pages, in order to comply with Commission Orders in the Companies' electric security plan, In re Ohio Edison Co., Cleveland Elec. Illum. Co., and Toledo Edison Co., for Auth. to Provide for a Std. Serv. Offer Pursuant to R.C. 4928.143, Revised Code, in the Form of an Elec. Security Plan, Case No. 12-1230-EL-SSO. Thereafter, on May 16, 2014, the Companies filed revised tariff pages for Riders RTP and CPP reflecting corrections to minor errors in the May 1, 2014 filings.
- (3) On May 20, 2014, the Commission's Staff filed comments on the Companies' filings. In its comments, Staff states that the Companies' calculation of Riders RTP and CPP are supported by adequate data and are properly allocated. Staff further recommends that the Commission approve the filings.

(4) The Commission has reviewed the Companies' revised tariffs and Staff's review and recommendations and finds that the revised tariff pages and rates are consistent with the Companies' electric security plan and do not appear to be unjust and unreasonable. Therefore, we accept Staff's recommendations and approve the Companies' revised tariffs.

It is, therefore,

ORDERED, That FirstEnergy's tariff pages and tariff rates for Riders RTP and CPP are reasonable and are approved. It is, further,

ORDERED, That FirstEnergy be authorized to file in final form four complete copies of the tariff pages consistent with this Finding and Order and to cancel and withdraw its superseded tariff pages. FirstEnergy shall file one copy in its TRF docket (or may make such filing electronically as directed in Case No. 06-900-AU-WVR) and one copy in this docket. The remaining two copies shall be designated for distribution to the Rates and Tariffs Division of the Commission's Utilities Department. FirstEnergy shall also update its tariffs previously filed electronically with the Commission's Docketing Division. It is, further,

ORDERED, That FirstEnergy shall notify all affected customers via bill message or bill insert within 30 days of the effective date of the tariffs. A copy of the customer notice shall be submitted to the Commission's Service Monitoring and Enforcement Department, Reliability and Service Analysis Division, at least 10 days prior to its distribution to customers. It is, further,

ORDERED, That FirstEnergy's updated Riders RTP and CPP should become effective on a services-rendered basis on June 1, 2014. It is, further,

ORDERED, That nothing in this Finding and Order shall be binding upon this Commission in any future proceeding or investigation involving the justness or reasonableness of any rate, charge, rule, or regulation. It is, further,
