**REPORT IN SUPPORT OF APPLICATION OF
EUREKA HUNTER PIPELINE, LLC
FOR AUTHORITY TO ABANDON SERVICE**

Now comes the Applicant, Eureka Hunter Pipeline, LLC (hereinafter "Eureka Hunter" or "Applicant"), and files a Supplemental Report in support of its Application for Authority to Abandon Service. Eureka Hunter has successfully coordinated alternative suppliers of natural gas for the subject customers and now offers the attached Stipulations and Release Agreements reflecting that Eureka Hunter's Application now stands uncontested. Therefore, Eureka Hunter now respectfully requests an Order granting Eureka Hunter's Application to Abandon Service.

Through Eureka Hunter's efforts, and the coordination of PUCO Staff, Eureka Hunter has successfully coordinated third party natural gas suppliers to assume servicing the subject customers. As a result of Eureka Hunter's efforts, the following customers have stipulated to Eureka Hunter's abandonment of service, as evidenced by the attached Stipulations and Releases¹:

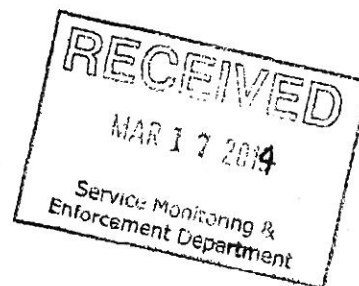

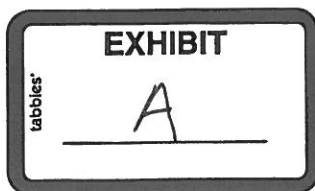
