**ANSWER, MOTION TO DISMISS, AND REQUEST FOR MEDIATION OF THE  
DAYTON POWER AND LIGHT COMPANY**

Now comes the Dayton Power and Light Company (“DP&L” or “Respondent”), by and through counsel, and for its answer to the Complaint filed in this docket by Michael and Kaye Sherman (“Complainant”), hereby states as follows:

1. On or about May 16, 2014, the Public Utilities Commission of Ohio (“the Commission”) accepted for filing a Complaint by Complainant alleging generally that DP&L improperly charged the customer’s account in connection with electric usage at the Complainant’s address.

2. The Respondent, DP&L, denies or is without sufficient knowledge to ascertain the veracity of all of Complainant’s allegations of wrongdoing as described in the Complaint and therefore denies the same. At all pertinent times, DP&L has complied with all relevant statutes, regulations, and approved tariffs.

3. Respondent further moves the Commission to dismiss this Complaint. To the extent that the Commission denies such motion, Respondent hereby requests the opportunity to mediate this issue with the Complainant to determine whether a mutually acceptable resolution is possible.
