Thank you for contacting the Ohio Power Siting Board (OPSB) in regards to the proposed Greenwich Windpark, OPSB Case No. 13-0990-EL-BGN.

The developer of the wind farm, WindLab, held a public informational at South Central High School on May 22, 2013 in accordance with Ohio Administrative Code requirements. Windlab's website hosts the materials that were shared with the public that evening: http://greenwichwindpark.com/opsb ("Open House Poster Presentation"). Additionally, the application was filed on December 24, 2014 and remains available to the public via the OPSB website (http://dis.puc.state.oh.us/CaseRecord.aspx?CaseNo=13-0990). Finally, the local public hearing was held on May 6, 2014 at South Central High School. Notice of this hearing was placed in the *Norwalk Reflector* on March 12, 2014 and the *Greenwich Enterprise Review* on March 18, 2014 by Windlab, in accordance with requirements.

As a current case pending before the Board, the comment period for this project is open and your comments will be docketed in the case file. The OPSB welcomes public comments on any project, including those under construction or operation.

The <u>Staff Report of Investigation</u>, filed on April 18, 2014, serves as the OPSB Staff's recommendation to the Board. The Staff's findings on possible impacts to recreational areas may be found on page 22 of the Staff Report. The nearest proposed turbine to a recreational area would be a turbine approximately 1.13 miles from the Greenwich Reservoir Park in the Village of Greenwich. Staff noted that the proposed wind farm will not alter the land use of any recreational land.

Please note that the taxation of a utility facility is not determined by the Ohio Power Siting Board. I would encourage you to contact Windlab or your county commissioners to learn more information about how this proposed facility would be taxed if and when it is certificated and constructed.
