Thank you for contacting the Ohio Power Siting Board (OPSB) regarding Windlab's proposal to construct the Greenwich Windpark (OPSB Case No. 13-0990-EL-BGN).

Your comments will be docketed within the case record. It is noted that you are opposed to the proposed project.

WindLab, held a public informational at South Central High School on May 22, 2013 in accordance with Ohio Administrative Code requirements. Additionally, a local public hearing was held on May 6, 2014 at South Central High School. Notice of this hearing was placed in the *Norwalk Reflector* on March 12, 2014 and the *Greenwich Enterprise Review* on March 18, 2014 by Windlab, in accordance with legislative requirements.

The Greenwich Windpark remains pending before the Board. Ultimately, the Board's seven voting members will make a decision whether or not to certificate the project.
