Dear Ms. McNeal:

The purpose of this letter is to bring to the attention of the Board that many of the letters written to the Board came after the above referenced matter had been submitted on the record. These letters are from property owners who are not in the Project area of the 6011 Greenwich Windpark. Our research on the addresses of the letter writers shows that of the seven different correspondents, all but one are outside the Project area and not an adjacent property owner.

Letters from Tim and Jessica Williams; Kurt & Elaine Barman; Don Rhine; Marcia Ledet; Sarah Kilgore; Valerie Malicki; and Tom Stacy in opposition to the project have been docketed.

Mr. and Mrs. Barman own property near Willard, Ohio and is 12 miles away from the Project area, while Mr. Stacy's property in Zanesville, is 78 miles away from the project.

Ms. Malicki is also outside the Project area and she is not an adjacent property owner. Her property line is 717 feet from the project boundary and it is 1.1 miles from the nearest turbine, Turbine 23. Likewise, Mr. Rhine's property is not adjacent to the Project area; it is 1,881 feet from the boundary line of the Project area and 1.2 miles from the nearest turbine, Turbine 23.

The property owned by Sarah Kilgore and Tim and Jessica Williams borders railroad property, not the Project area. The railroad property is adjacent to part of the northern boundary of the Project area. Thus, since the owners are not adjacent property owners, they very likely did not receive the letter sent to property owners on March 12, 2014.

As an additional fact, the closest turbine to Mrs. Kilgore's property is Turbine No. 24 which is 2,299 feet or nearly a half mile away. Turbine 24 is also the closest turbine to Mr. & Mrs. Williams' property and it is 2,328 feet away, also nearly a half mile away.

Ms. Ledet owns three parcels near the Project area; two of them do not border the Project area boundary, one of them does. She is the only one of those who wrote letters who is an adjacent property owner. The nearest turbine to this adjacent property is Turbine 24, which is 1,383 feet away.


