



**MOTION FOR PROTECTIVE ORDER**

Through undersigned counsel, M3 Consulting, LLC dba M3 Energy (hereinafter "M3 Energy") hereby moves for a protective order barring discovery of Exhibits C-3 and C-5 "Financial Statements" and "Forecasted Financial Statements," respectively, to the Certification Application for Competitive Retail Natural Gas Brokers/Aggregators filed by M3 Energy pursuant to Ohio Administrative Code Chapter 4901-1-02(E).

M3 Energy is a privately held Limited Liability Company and its financial information is not part of the public record in any jurisdiction. M3 Energy's financial information constitutes trade secrets under Ohio Law. The disclosure of such information would be detrimental to M3 Energy in the competitive retail gas market as competitors may obtain sensitive financial and business plan information. Non-disclosure of its financial information is consistent with Title 49 of the Ohio Code. Therefore, M3 Energy hereby moves for a protective order barring discovery of Exhibits C-3 and C-5 and further requests the Public Utilities Commission of Ohio treat Exhibits C-3 and C-5 as confidential and not disclose the financial information or any information contained therein to any person not responsible for reviewing the application.
