Thank you for contacting the Ohio Power Siting Board regarding the proposed Greenwich Windpark in case number 13-0990-EL-BGN. This case remains pending before the Board. Your correspondence in opposition to the proposal will be docketed in the public comments section of the case record that is available for the Board's review.

Windlab held a public informational meeting at South Central High School on May 22, 2013. Additionally, the Board held a local public hearing in Greenwich on May 6, 2014 to gather testimony from the community.

Before the Board makes a decision, it will consider the complete record in the case, including Windlab's application, the staff report, and the transcripts from the public and adjudicatory hearings. These documents, as well as an interactive map that indicates the location of each turbine, are available on Ohio Power Siting Board website.
