Due to a typographical error in the original compliance tariff filing, the non-residential SDRR rate was listed as \$9.32/month instead of \$9.82/month. The residential rate was listed correctly in the original compliance tariff. I apologize for any confusion that may have caused. AEP Ohio requests Commission approval of this corrected compliance tariff and has listed the effective date as Cycle 1 August 2014 in anticipation of an entry authorizing implementation of the new SDRR rate for non-residential customers.
