On May 2010, Just Energy Group Inc. a publicly traded Corporation (TSX: JE and NYSE: JE) (Formerly Just Energy Income Fund) indirectly acquired all of the issued and outstanding membership interests of Hudson Parent Holdings, LLC and shares of the capital stock of Hudson Energy Corp. (collectively, “Hudson”).

Hudson Energy Services LLC an approved energy supplier and an affiliate of Hudson Energy Corp., it is also a subsidiary of Just Energy. Hudson Energy Services LLC will continue to operate as a separate subsidiary of Just Energy and will also continue to serve its current base of customers as well as market to new customers.

Exhibit D-1 “Operations”

Hudson is a third party electricity and natural gas supplier that provides customer choice and competitive pricing to businesses. The applicant contracts bilaterally with wholesale energy suppliers to serve its retail load and to fulfill other requirements, such as filling natural gas storage facilities and balancing supply pools. Contract purchases range from daily spot structures to yearly supply acquisitions.

Hudson manages its own customer back office functions including accepting new customer contracts, enrolling accounts with local utility companies, calculating bills, and responding to customer inquiries. These functions are managed primarily by staff located in New York and Texas.

Exhibit D-2 “Operations Expertise”

Hudson operations department handles all nominations and scheduling of the purchases referenced in Exhibit D-1, retail load and other company requirements. The analysts monitor the individual markets and the marketplace closely. They are on call 24 hours a day to ensure that all necessary pipeline and utility requirements are met. The supply operations department is responsible for nominations, balancing, scheduling and purchasing requirements in-house for both gas and electric in all U.S. markets. This department is shared among all affiliates of Just Energy Group and as such also manages the operations for Hudson Energy Services, LLC. which is currently active in Ohio.
