Thank you for contacting the Ohio Power Siting Board (OPSB) regarding the Greenwich Windpark, OPSB Case No. 13-0990-EL-BGN. I will docket your letter in the public comments section of the case record.

As you mentioned, the Board held a local public hearing in Greenwich on May 6, 2014. On May 16, Windlab, the Ohio Farm Bureau Federation, and the OPSB Staff filed a joint stipulation and recommendation to the Board. Later, on May 19, the Board held an adjudicatory hearing in Columbus.
