**Attachment to the Petition for Reallocation of Electric Service Territory  
Jointly Filed by Ohio Power Company and Carroll Electric Cooperative Inc.

**Reason for Reallocation:** Cardinal Gas Services, L.L.C. ("Cardinal") operates the Carrollton Compressor Facility, a natural gas compressor station in Lee Township, Carroll County, Ohio. Cardinal is expanding and constructing additional compressors at the Carrollton Compressor Facility located at 1414 Panda Road, Carrollton, Ohio 44615. The Carrollton Compressor Facility is currently located entirely within the certified service territory of Carroll Electric Cooperative, Inc. ("Carroll" or the "Cooperative"). The additional compressors are in need of a high-voltage electrical supply. Ohio Power Company ("Ohio Power"), which has the necessary facilities within roughly 0.5 miles of the site of the additional compressors, is willing and able to provide high-voltage electrical service to the additional compressors. After discussions, Cardinal, Carroll and Ohio Power have agreed that the portion of Carroll's service territory in which the additional compressors will be located should be transferred from Carroll to Ohio Power so that Ohio Power may serve the additional compressors, estimated to be an approximately 14 megawatt new load.

It is noted that Carroll will continue to serve the existing facilities at the Carrollton Compressor Facility, an approximately 0.75 megawatt load, and any new facilities at the Carrollton Compressor Facility to be located in Carroll's certified service territory. The parties have agreed that the existing facilities at the Carrollton Compressor Facility served by Carroll constitute a load center separate and apart from the additional facilities to be located in the portion of the Cooperative's service territory to be transferred to Ohio Power under this Joint Petition, regardless of whether such existing facilities are served from distribution or transmission voltage facilities, so long as such existing facilities remain located in the Cooperative's certified service territory. The existing facilities at the Carrollton Compressor Facility are currently served by the Cooperative from the Cooperative's distribution voltage facilities.

**Metes and Bounds/Detailed Description of Reallocation:**

Situated in the Township of Lee, County of Carroll, State of Ohio and being a part of the Southwest Quarter of Section 12, the same being a part of the lands now or formerly owned by Brian L. Wagner, as recorded in Exhibit "A" in Instrument Number 201000001812, and further bound and described as follows:

Beginning at an Iron Pin found (#5 Rebar) in Panda Road, a 50 foot right-of-way, on the South line of Section 12 and the North line of Section 11, said point being the same corner as called out in call 3 of said Exhibit "A";

Thence N 78°43'44" E a distance of 525.57 feet to a point and the TRUE PLACE OF BEGINNING for the tract of land herein to be described;

1. Thence N 09°47'18" E a distance of 245.94 feet to a point;
2. Thence N 71°40'21" E a distance of 265.54 feet to a point;
3. Thence S 80°12'42" E a distance of 192.06 feet to a point;
4. Thence S 09°47'18" W a distance of 242.20 feet to a point;
5. Thence N 80°12'42" W a distance of 174.46 feet to a point;
6. Thence S 09°47'18" W a distance of 128.87 feet to a point;

7. Thence N 80°12'42" W a distance of 282.40 feet to the true place of beginning.

The above described tract of land contains 2.869 acres of land, more or less, as surveyed and determined in May of 2014 by BL Companies. The basis of bearing, as called out in said Exhibit "A" N 02°26'19" E for said property line of Brian L. Wagner, is taken from said Brian L. Wagner dead.

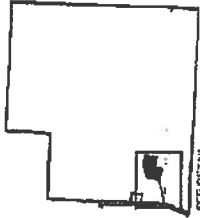

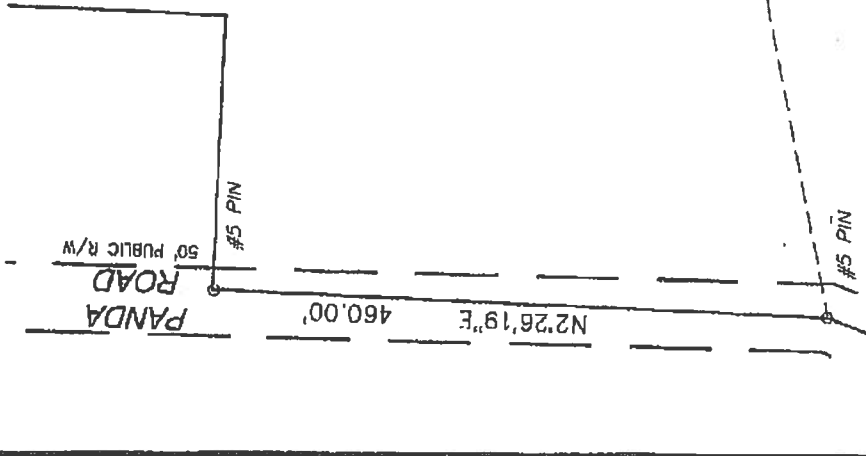

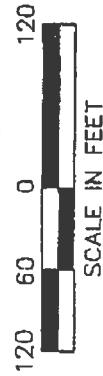
