Thank you for contacting the Ohio Power Siting Board (OPSB) regarding the proposed Greenwich Windpark (OPSB Case No. 13-0990-EL-BGN). Your comments will be docketed in the case record.

The OPSB Staff Report of Investigation summarizes the OPSB Staff's investigation of probable impacts and serves as the Staff's recommendation to the Board. Among other things, the Staff noted that under Ohio Revised Code Section 4906.10(A)(1), the basis of need is not applicable to the certification of a generation facility. Basis of need is required only for transmission facilities. The OPSB reviews each project based on its own merits, regardless of generation type.
