Iron Energy LLC in accordance with Sections 4928.64 and 4928.65, Revised Code and Commission Rules 4901:1-40-03 and 4901-40-05 hereby submits this Alternative Energy Annual Status Report.

### I. Determination that an Alternative Energy Resource Report is required

During the calendar year 2013, Iron Energy LLC states that it conducted retail sales of generation to customers who utilized the generation in a load center located in the state of Ohio.

- a. Column (a) above lists the unadjusted number of Solar and Total RECs required for Iron Energy LLC in 2013. The determinations were calculated by multiplying the baseline sales (actual sales) by 0.090% for Solar RECs and 2.0% for Total RECs. Total RECs include both Solar and Non-Solar RECs.
- b. Iron Energy LLC states that is has obtained the number of both Solar and Non-Solar RECs listed in column (b) above for 2013.
- c. Iron Energy LLC used the PJM GATS registry for the RECs detailed above.
- d. Iron Energy LLC states that of the RECs it has obtained for 2013 the number listed in column(d) represents the RECs with generation facilities sited in the state of Ohio.
