COMMENT DESCRIPTION:

I read with interest the letter submitted by Mr. Scott Cormany opposing the new preferred route through the Pleasant Valley Wildlife Area. He states that it would be irresponsible for AEP to move the transmission line away from the developments and customers it is supposed to serve.

That is exactly the point. The majority of properties and farmland effected by the old Blue Route are not AEP customers. We are South Central Power customers. There is absolutely no benefit to have AEP power lines near or on our land.

AEP is making, in my opinion, the reasonable and correct decision in moving the new preferred through the Pleasant Valley Wildlife Area where some existing power lines already run. The new preferred route will effect the least number of homes, the least number of families, and away from out schools.

I strongly support the new preferred route that AEP has proposed.
