Effective September 1, 2014, our local telephone rate for residential customers will increase by \$1.25 per month as listed in the table below. Many rural telephone companies, including Champaign Telephone Company, receive support from the Federal Universal Service Fund (FUSF). New rules reduce such support if a telephone company's local rates are below the national average. The \$1.25 increase is necessary to bring our residential local rates more in line with the national average and to avoid a reduction in our FUSF.
