COMMENT DESCRIPTION:

I am requesting the OPSB deny an amendment to the certificate of the Buckeye Wind application. The 'Company' contends that ongoing litigating of Champaign Wind, a separate project according to record, is delaying construction of the Buckeye Wind project. However, during proceedings of Champaign Wind, the 'Company' consistently claimed the two projects were separate. To now request an amendment extending the application of Buckeye Wind due to litigation of Champaign Wind, further solidifies that these projects are one in the same. The public should have the opportunity to comment and an amendment should not be allowed. Since these are separate projects, according to the 'Company,' nothing has prevented them from commencing construction of Buckeye Wind. EverPower is clearly trying to dodge recent legislative changes that will take effect later in the year. Please reject EverPower's request to amend their certificate of the Buckeye Wind application.
