Curriculum Vitae

Jeffrey Mayer serves as CEO of Soluxe Inc., a new marketer of solar and energy efficiency products and financing products to commercial buildings and homeowners throughout the US.

Until 2011 Mr. Mayer served as CEO and President of MXenergy, now a unit of Constellation Energy Group since its sale in July 2011. At the time of the sale, MXenergy was one of the nation's largest retail marketers of natural gas and electricity to residential and small commercial customers.

Prior to MXenergy, Mr. Mayer was a managing director of AIG Trading Corporation and Sempra Energy Trading Company from 1993-1999. During this period he also served as President of AIG Securities Corporation and AIG Clearing Corporation. From 1987-1993 Mr. Mayer was a vice president of Goldman Sachs & Co. where he headed its energy futures business.

Mr. Mayer joined Goldman Sachs & Co. in 1984 as chief counsel of its J. Aron Commodities Division after a brief career in private practice as an attorney with Barrett Smith Schapiro Simon & Armstrong in New York, NY.

From 1997-2009 Mr. Mayer served as an elected member of the Board of Finance of Westport, CT, the budgeting and tax setting body in town. From 2005 through 2009 he served as Chairman of the Board. He currently serves on the board of the Magellan Fuel Solutions, a Toronto-based marketer of fixed price gasoline to vehicle fleets. He also serves on the board of iiConn, a non-profit entity in Connecticut that is responsible for resettling political refugees and providing social services to over 7000 immigrants in the state.

From 1999-2005 Mr. Mayer served as an independent member of the Risk Oversight Committee of Northeast Utilities.

Mr. Mayer is a 1973 graduate of Yale University and received his LL.B. from New York University in 1978. From 1995-99 he created and taught the Energy Traders' Institute, a risk management program for executives of utilities and regulators throughout the country sponsored by Infocast. As an amateur historian he has taught a class in Civil War History for many years in the Continuing Education program of the Westport Public Schools and has given lectures on local history before several groups throughout Fairfield County, Connecticut.
