We kindly request the option to maintain our current electric customers under the Ohio Gas & Electric name and conduct future marketing under the U.S. Gas & Electric name.

There will be no changes to the corporate structure of the company. Energy Services Providers, Inc. will remain the entity receiving the releases to pipeline and storage capacity.
