After having researched this I have concluded there is simply way too much conflicting information to proceed with the project. I think it's a forgone conclusion that if they are installed they are here to stay. Among the concerns I have, first and foremost is the concern for the health of those residents that will be near the windmills, some are my own family. Although my wife and I live in Greenwich township its my understanding the proposed locations of the windmills are at a distance that will not affect us. We do, however have a daughter, son-in-law, and five grandchildren that live on property that is located right in the middle of where several of these windmills are likely to be located. They own the property so they could even benefit financially from this project, but health concerns trump anything they might receive in regards to financial remuneration. I have talked with Firelands Electric Cooperative officials as well as AEP officials I have known for many years and they are convinced there is no benefit in trying to generate power from the windmills. They concur that there are too many unanswered questions and don't believe the electric rates will be lowered as a result of the power that could be generated from the windmills. As a matter of fact they have told me the rates as best they can determine will increase. I understand those reading this are probably under pressure from the government to approve these applications because of misguided elected politicians in DC. I urge you to simply do a few things before making your decision as follows :

- 1.) Ask yourself if you would want these windmills placed near your residence.
- 2.) Visit some folks who live near these windmills and ask them how their living conditions have changed since they have been installed.
- 3.) Visit some folks who have had to move out of their homes after windmills have been installed because of the side affects from the noise generated from the windmills.
