We downloaded your letter to the Ohio Power Siting Board (OPSB) that was submitted on Aug 19 2014. This email is in response to it. I sent 1 survey to the OPSB on Aug 1 2014. The survey was straight forward and really needed no explanation. A blank copy of the signature page is attached to this email. I don't see how anyone could be confused by the wording. I don't see your complaint that a number of signatories are those who have leased their land to your client. We didn't see any signatures, that are from the 29 property owners listed for this project, on the survey.

On the

map dated 8/8/2014 the red dots represent some of the signatories residences. From this maps I only see 2 red dots in the project area, if that is the number of questionable signatures that you referred to. 1 by turbine 9 and the other by turbine 23. Since you neither disclosed the addresses or the signatures, that are in dispute, I figured the addresses are 4511 Ohio 13, Greenwich, OH and 3031 Alpha Rd, Greenwich, OH. Both of these properties are listed as adjacent properties to the project, they are not leased. Maybe these signatures shouldn't have been counted on this survey, they should have been counted on the adjacent landowners survey. That survey was filed with the OPSB on July 22 2014. In that survey the adjacent landowners are overwhelmingly against 6011 Greenwich Windpark LLC. Unless I'm missing something here I can't understand your complaint. As for it being illogical for someone who is being paid to have anything bad to say about the project, why is there a confidentiality clause in the lease?
