To Whom It May Concern:

I believe you are aware of the attempt of most of our community to stop the erection of wind turbines on the property of a very few. Each meeting we've held has been well attended and each has more voters than the one before. I am vehemently against the building of industrial wind turbines in Greenwich. Our dairy farm is an adjacent land owner and we, our health and the health of our animals are at the mercy of very few.

At a recent meeting, Mark Sheildcastle, Research Director from Black Swamp Bird Sanctuary by Oak Harbor, reputed studies about bird and bat deaths. One thing he told, while demonstrating the silliness of the "official" studies, was how a songbird that is hit by a blade is propelled very distant from any turbine site and will never be found. If it is found it will just be a puff of scattered feathers. Not to mention that predators will carry off kill before any count can be made. We have many, many bald eagle sightings in our township (especially in the range of the proposed turbines) and though I guess turbines now have permission to kill them most would agree that that is wrong on many counts. There is NOTHING good for the environment about turbines and it's a complete fallacy that they are "green"!

Please hear the plea of our community and help save our little town and do not vote these monstrosities into existence.

I am writing you to ask for your help in vetoing the proposed wind park in Greenwich, Ohio. I am an adjacent landowner to one of the leased farms.


