Re: Change in Boundary between the Akron Exchange of AT&T Ohio and the Montrose Exchange of Frontier North, Inc.

Dear Ms. McNeal:

AT&T Ohio and Frontier North, Inc. (the "Joint Applicants") propose a boundary change for the Akron exchange of AT&T Ohio and the Montrose exchange of Frontier North, Inc. This application is being filed pursuant to Ohio Administrative Code §4901:1-6-32(B). AT&T Ohio and Frontier North, Inc. will work with the Commission Staff to revise the topographical maps to reflect the incorporation of a small portion of the AT&T Akron exchange into the Montrose exchange of Frontier North, Inc. This is an administrative change only made to reflect the current serving arrangements that have been in place for many years.

This boundary change affects an area south of Ridgewood Road and west of Interstate 77 in the AT&T Ohio Akron exchange. Set forth below is the proposed boundary change:

- The western boundary line of the AT&T Ohio AKRNOH86 exchange to be moved from its current location, 900 feet eastward at Ridgewood Road and 1,650 feet northeastward at Schocalog Road to the centerline of Interstate 77 (See enclosed map.) so that this area is incorporated into the Frontier North, Inc. MTRSOHXADS0 exchange.

Frontier North, Inc. serves the customers today in the affected area and will continue to serve customers in the future.

The Joint Applicants are in concurrence with this change, and confirm that this change will not adversely affect the service being furnished to any existing subscriber.

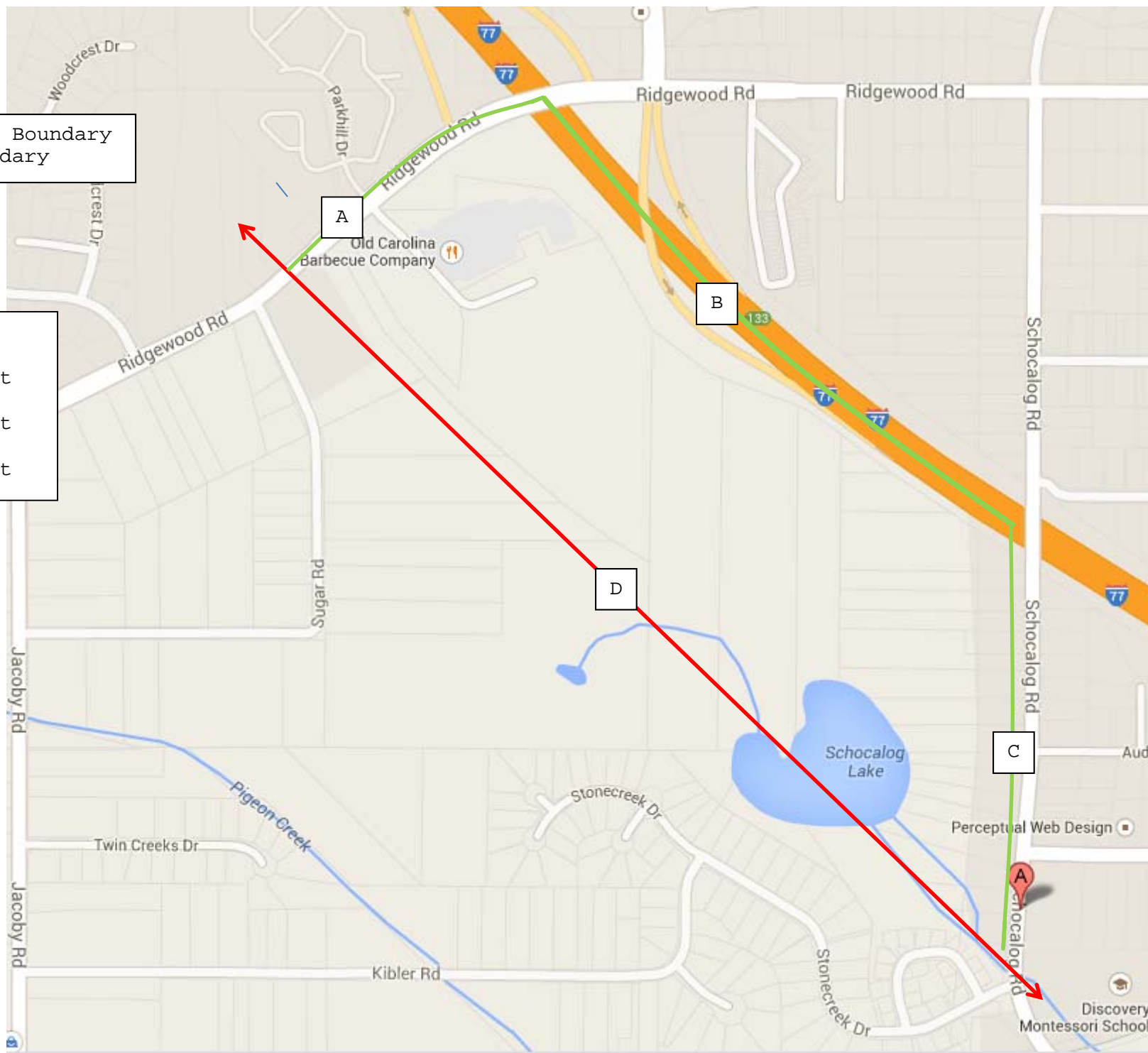
