Mark S. Yurick (#0039176), an active Ohio attorney in good standing, has agreed to associate with Movant on this case.



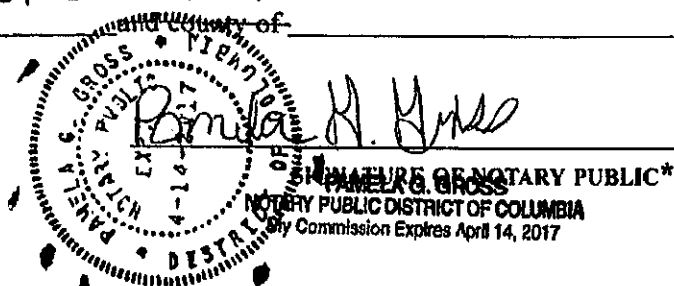


