

Effective on September 1, 2014, Telephone Service Company will implement a revised rate schedule for basic local exchange service for customers throughout its exchange areas. The affected services and revised rates will be as follows:

<u>Cridersville &amp; Wapakoneta</u>	<u>Current Monthly Rate</u>	<u>New Monthly Rate</u>
Primary Access Line Business:	\$12.45	\$13.70
Primary Access Line Residential:	\$8.75	\$10.00
