Dear Customer:

This letter is to inform you of an increase that will occur in the rates you pay for water from Camplands Water LLC.

On July 26, 2013 Camplands Water LLC filed for a rate increase with the Public Utilities Commission of Ohio ("PUCO"). On June 4, 2014 the PUCO, in Case No. 13-1690-WW-AIR, authorized an increase of \$48,446 or approximately 19.3%. The new monthly rate for Lake Village Club Inc. will be \$5,666.00 and the new monthly rate for Holiday Camplands Association will be \$18,968.75. The Public Utilities Commission of Ohio approved new rates to be effective on September 1, 2014.

The Association and the Company shall agree on a target date for the work to be completed. The Company shall make every reasonable effort to meet the target date, subject to: employee availability; the payment for the service being made to the Association; and the Association lot owner having his service line installed and ready to be connected by the Company. The Association shall accept payment from lot owners. The Association shall pay the Company 50% of the Winterization Service fee prior to the work commencing and 50% when the work is completed. The Company shall restore the condition of the lot owner's property to the same state it was prior to the winterization work commencing. The Association shall be indemnified, defended and held harmless by the Company from any and all claims arising out of, or based on: 1) any damage or injury to lot owners or their property as a result of the Winterization Service; and 2) any damage or injury to the Association, its employees, and third parties as a result of the installation of the Winterization Service.
