Dear Examiners Price and Chiles:

Pursuant to Commission Order in Case No. 12-1230-EL-SSO<sup>1</sup>, Ohio Edison Company, The Cleveland Electric Illuminating Company, and The Toledo Edison Company (the Companies) have filed the Advanced Meter Infrastructure/Modern Grid Rider (Rider AMI) report that the Companies are required to file in February of each year. The Staff of the Public Utilities Commission (Staff) has reviewed the 2013 report and believes the Companies have satisfied their annual filing requirement for the year 2013 and that no changes to the report are needed.

However, Staff recommends that the Commission should order the Company to file these annual reports in a separate case record with its own docket number, distinct from filings related to revisions of tariff pages. This will allow Staff to more easily identify the filing of the report so that Staff can review the report more efficiently. It will also prevent the annual report from getting confused with other documents and issues in the case record and thus enable intervenors and interested parties to locate the report
