REVISED APPLICATION

On September 23, 2013, Eastern Natural Gas Company, Pike Natural Gas Company, and Southeastern Natural Gas Company (Companies) filed an Application for approval of new bill formats. On November 5, 2013 the Commission ordered that the Application filed by the Companies be suspended from the automatic approval process. The attorney examiner found that additional time was necessary in order to complete a review of the Application and the cases should be suspended from the automatic approval process in order for the Commission and Staff to review the Application further.

Since the date of the original filing the Companies have engaged in an ongoing review process with the Commission Staff which has resulted in the set of sample bill formats for which the Companies are seeking approval. Additionally, as the new billing system matures and expected upgrades to the software are implemented in 2015, the Companies will continue to modify their billing formats to reflect the enhancements that have been made available. These anticipated future revisions will be filed with the Commission for its review and approval prior to implementation.

Finally concerning a related topic, the Companies wish to inform the Commission of their new online application. The Companies are making available to their customers online bill payment. This application will allow customers: to review their current bill online; pay their bill online, including a credit card payment; and review actual copies of their prior twelve months of bills.

Now, the Companies respectfully requests that the Commission review and approve the attached sample bill formats. Attachment A contains samples of the front page of the proposed bill formats. Bills samples are actual bills with the customer name, address, and account number

redacted. Attachment A, with the exceptions of the company name and return address are identical for each company.

- Attachment A, contains for Eastern Natural Gas Company: a bill face for a
 customer that is not on a payment plan (regular bill); a bill face for a customer on
 budget bill; a bill face for a customer on PIPP, and a bill back that would apply to
 all.
- Attachment B, contains for Pike Natural Gas Company: a bill face for a customer
 that is not on a payment plan (regular bill); a bill face for a customer on budget
 bill; a bill face for a customer on PIPP, and a bill back that would apply to all.
- Attachment C, contains for Southeastern Natural Gas Company: a bill face for a
 customer that is not on a payment plan (regular bill); a bill face for a customer on
 budget bill; a bill face for a customer on PIPP, and a bill back that would apply to
 all..

In support of its Application, the companies state the following:

- The Companies are Ohio corporations engaged in the business of supplying natural gas to consumers located within the state of Ohio. The Companies are public utilities subject to this Commission's jurisdiction and the customers of the Companies are served pursuant to each company's approved tariffs.
- 2. Each company, as of December 12, 2012, is a wholly owned subsidiary of Utility Pipeline Ltd, Inc., which is an Ohio corporation.
- 3. The transfer of ownership from the previous owner Clearfield Ohio Holding was approved in the Commission's Findings and Order in Case No. 12-2792-GA-UNC, dated December 12, 2012.
- 4. The local offices of the Companies and their service areas are:
 - Eastern Natural Gas: Principal address is 5940 State Route 7, Kinsman,
 Ohio 44428. It serves approximately 6,500 customers in the eastern portion of Ashtabula and Trumbull counties in Ohio.
 - Pike Natural Gas: Principal address is 144 Bowers Ave., Hillsboro, Ohio 45133. It serves approximately 7,000 customers in Clinton, Highland, Pike, Jackson, and Ross counties in Ohio.
 - Southeastern Natural Gas: Principal address is 4455 Walnut Rd., Suite E, Buckeye Lake, Ohio 43008. It serves approximately 1,500 customers in Perry, Hocking, Athens, Morgan, Washington, Delaware, Union, Pickaway, Fairfield counties in Ohio.
- 5. The Companies customer billings from December 2012 thru June 2013 were provided by the previous owners, Clearfield Holdings using the bill format

- approved by the Commission in its Findings and Order in Cases No. 09-1039, 1040, and 1041-GA-UNC.
- The Companies parent company Utility Pipeline Ltd. starting with the July 2013 bills, is now responsible for the Companies customer billings.
- 7. Utility Pipeline Ltd. to accommodate the addition of the Companies to its billing system, contracted with an outside company to develop a new billing system, which has necessitated modifications in the bill formats.
- 8. Since the date of the original filing, September 23, 2013 the Companies have engaged in an ongoing dialogue with the Commission Staff which has resulted in the sample bill formats being filed for approval.
- 9. Ohio Administrative Code §4901:1-13-11(D) requires any natural gas company under the Commission's jurisdiction to submit to the Commission for its approval any proposed new bill format, and further provides that in the absence of any action by the Commission within forty-five day, the proposed new bill format automatically shall be approved on the forty-sixth day.

WHEREFORE, the Companies respectfully request that the Commission review and approval the new bill format.

UNDERSTANDING YOUR BILL

Gas Cost Recovery (GCR) - The cost of gas purchased by the company for sale to its customers.

Delivery - The charge billed each month for the delivery of gas from its origin to the meter.

Customer Charge - a monthly charge to cover various costs such as maintaining the gas lines that serve you, meter reading and billing, and 24 hour emergency response costs along with other operating costs.

Late Payment Charge - If your payment is not received by the due date, your account is subject to be charged a late payment charge.

Gross Receipts Tax - Ohio tax levied on public utilities.

Actual Reading - a meter reader physically reads your gas meter.

Estimated or Calculated Reading - during the months we don't read your meter, your bill is based on previous gas usage, gas rates and the weather. An estimated or calculated bill will be verified the following month when your meter is read.

CCF - 100 cubic feet of gas; a measure of gas usage.

MCF - 1000 cubic feet of gas; a measure of gas usage.

Ending Balance - The total current account balance.

FOR YOUR SAFETY

Make sure your gas appliances are properly installed and adjusted. Check venting systems. Call a qualified service company for needed repairs.

In accordance with governmental regulation, we ensure that there is a distinct odor to natural gas for your safety.

- If you smell gas, leave the house...immediately! Don't light matches or flip an electrical switch.
- call 1-888-784-6160, the gas company's 24-hour emergency service, from a telephone other than your own.
