



MEMORANDUM IN SUPPORT OF AMENDED
MOTION FOR PROTECTIVE ORDER

By this reference, FNE adopts and incorporates as if fully rewritten herein the reasoning set forth in its Motion for Protective Order on September 12, 2014 seeking protective treatment of the information contained in Exhibits C-3, and C-5 of its Renewal Certificate Application. The same reasoning applies with equal force to the confidential information contained in Supplemental Exhibits C-4. The information contained in Supplemental Exhibit C-4, as well as that in Exhibits C-3, C-4, and C-5, represents confidential business information, qualifies as trade secrets under Ohio law, and is to be protected from public disclosure.

Wherefore, FNE respectfully requests that: (1) its Motion for Protective Order of September 12, 2014 to be amended to include the information contained in Supplemental Exhibit C-4; (2) a determination be made that the information contained in Supplemental Exhibit C-4, as well as Exhibits C-3, C-4, and C-5, constitutes "trade secrets" as defined under Ohio law and Commission rule; and (3) the designated information be protected from public disclosure by granting the requested Motion for Protective Order.
