 - (b) Ohio Power Company, Ohio Edison Company, The Cleveland Electric Illuminating Company, The Toledo Edison Company, The Dayton Power and Light Company, and Duke Energy Ohio, Inc. (jointly, Electric Utilities); and
 - (c) Fiber Technologies Networks, LLC (Fibertech).
- (3) On September 10, 2014, memoranda contra were filed by Frontier North Inc. (Frontier North); The Ohio Cable Telecommunications Association; The Ohio Telecom Association; AT&T Entities; tw telecom of ohio llc; Fibertech; PCIA-The Wireless Infrastructure Association and The HETNET Forum; and Electric Utilities.
- (4) On September 19, 2014, Frontier North filed a motion for leave to amend its memorandum contra. In support of its request, Frontier North explains that it is seeking to amend its filing of September 10, 2014, to reflect the signature of Carl A. Aveni as counsel of record.
