Omega Crop Co. has requested a rehearing based on information submitted on 09.23.14.

Please honor a fair and just due process that was recommended to Omega verbally at the hearing, i.e. that Omega would be allowed to have a rehearing after the August 25, 2014 date. Again, this was stated on August 25, that a rehearing would be granted at a later date; this was how the board would fairly represent the 97% of adjacent landowners and hundreds of citizens against this project.

In fact, Windlab's Monica Jensen continues to assert that her over three year secret process of "signing up" leaseholders is GOOD for the entire community - so she nor her lawyer should have no objections to simply PROVING her case openly and honestly.

If they object, what do they have to hide?

Open disclosure and honest, scientific research and information to all affected citizens, especially those impacted, is all we are asking. Their report shows over 200 homes will have strobe lighting for over 20 seconds 100 times a week.

They assert the infrasound is safe, while Denmark has a cap on how much infrasound is allowed in each home. Windlab refuses absolutely to answer questions about predictions of infrasound - one example of simple easy basic information our honest hard-working good community deserves to know.

Emmett Robinson, our local bright Harvard grad, deduced mathematically that this project would increase Ohio's electrical output by about .04% at full capacity. But we all know a project like this will average about 27% efficiency. This , therefore, equals an increase in Ohio's electrical output of .0138% (see his letter).

The project will cost \$120 million, just to construct, and will increase Ohio's electrical output by .0138%! As this bright gentleman asserts, it makes NO sense.

Australian Windlab stockholders will get to buy new yachts, while Ohio rural residents will suffer with shadow flicker maybe 100 times a week for 20 second intervals and that is ok - all at the decision of this very agency.

If this project is so very wonderful , Windlab will not object to a fair open honest scientifically-based re-hearing, with INDEPENDENT RESEARCH presented.
