NOTICE OF CLARIFICATION OF INTERSTATE GAS SUPPLY, INC.

On October 1, 2014 Interstate Gas Supply, Inc. ("IGS") filed an Application for Waiver of Rules 4901:1-29-06(D)(6)(b) and 4901:1-21-06(D)(1)(h) of the Ohio Administrative Code ("OAC") that relate to third party verifications ("TPVs") ("Waiver Application") in the above captioned proceedings. After further review of its Waiver Application, IGS would like to clarify two paragraphs set forth in the Waiver Application.

First, IGS would like to clarify paragraph 10 of its Waiver Application to note that IGS is only requesting a waiver of the TPV rules set forth in OAC 4901:1-29-06(D)(6)(b) and 4901:1-21-06(D)(1)(h). IGS is not requesting waiver of any other rules that relate to TPVs other than OAC 4901:1-29-06(D)(6)(b) and 4901:1-21-06(D)(1)(h).

Second, IGS would like to clarify paragraph 7(f). In paragraph 7(f) IGS explains that, as part of the Home Energy Consultant ("HEC") Enrollment Process, IGS gives the customer the option to enroll via a wet signature on a physical copy of the terms and conditions, rather than electronically via a tablet computer. IGS would like to clarify that if the customer elects to enroll via a physical wet signature contract, IGS would still follow the TPV requirements set forth in OAC 4901:1-29-06(D)(6)(b) and 4901:1-21-06(D)(1)(h). Thus, IGS is only requesting a waiver

for electronic enrollments as described in paragraph 7 of the Waiver Application and not enrollments effectuated via a physical wet signature contract.

IGS respectfully requests that the Commission accept this Notice of Clarification in consideration of the Waiver Application.
