In addition, the nature and extent of LHNU's interest in the proceeding is supplemented with an additional issue: LHNU is concerned that the passage of Senate Bill 310 into law, which freezes the renewable and alternative portfolio standards in Ohio for two years, has eliminated the need for the Scioto Ridge Wind Farm. The Board issued the certificate in the original cases based, in part, on the wind farm's contribution to Ohio's portfolio standards. Now that the future of the portfolio standards is in jeopardy, the Board should reevaluate the need for the Scioto Ridge Wind Farm. The LHNU respectfully requests that this issue be heard at an evidentiary hearing at the Board.
